



## EZ Claim Pay for AARP Medicare Supplement Plans

Beginning January 12, 2022, *EZ Claim Pay* will be available to members enrolled in AARP® Medicare Supplement Insurance Plan G from UnitedHealthcare®. This new service aims to give members an easy way to pay their annual Medicare Part B deductible out-of-pocket expense to their medical providers. *EZ Claim Pay* will be available to all new and existing AARP Medicare Supplement Plan G members in Colorado, Indiana, Missouri, Oregon and South Carolina.



New and current Plan G members in the states above will receive information from UnitedHealthcare about *EZ Claim Pay*. Members will be mailed a [letter](#) detailing this service as well as an *EZ Claim Pay* paper [enrollment form](#).

- Plan G holders can call 1-877-223-1628 if they have questions about the service or need help filling out the enrollment form. At this time, enrollment into *EZ Claim Pay* can only be done by completing a paper enrollment form.



### **Remove the Hassle. Set it and Forget it!**

With the new *EZ Claim Pay* service, members won't need to keep track of the amount owed to their providers to satisfy their Medicare Part B deductible out-of-pocket expenses. UnitedHealthcare can do it for them! By using this service, members can choose to have UnitedHealthcare pay their Part B deductible expenses on their behalf automatically via Electronic Funds Transfer (EFT) from their checking or savings account at no additional cost.

The member can choose from two payment options:

- **Pay up front** - The full annual Medicare Part B deductible amount will be withdrawn directly from the member's bank account. UnitedHealthcare will pay the provider the applicable deductible amount when a claim is received.
- **OR**
- **Pay per claim** - As each Medicare Part B claim is received, the applicable deductible amount will be withdrawn directly from the member's bank account and UnitedHealthcare will pay the provider.
