How It Works

The smaller bonus (based on either life application count or life premium) will be paid. A few examples will illustrate how it works.

- 5 paid life applications and \$4,000 life premium = \$450
- 3 paid life applications and \$20,000 life premium = large case bonus \$1,000
- 9 paid life applications and \$10,000 life premium = \$1,200

The Fine Print

- Life applications issued and paid after August 1, 2017 are eligible.
- FOCUS 10 Life, Excel Performance VUL, FLX Living Benefits Term and all policies issued by Ameritas Life Insurance Corp. of New York are excluded.
- Planned life annualized premium will be used to determine the amount of premium paid for all products, including universal life.
 For universal life, the base planned annualized premium up to target will be credited and excess over target premium will not. For whole life, no paid-up riders or 1035 premium will be credited. Minimum planned annual premium is a total of \$120.
- An annual premium increase on an existing life policy must be at least \$120 to be considered for the application count.
